## Sub: Participation in ATMA Tests for PGDM/MBA Admissions of 2015-16

At the outset, let me express my heartfelt thanks to all those institutes who have supported ATMA during the last one year.

AIMS Test for Management Admissions (ATMA) is one of the six (ATMA, CAT, CMAT, GMAT, MAT and XAT) National Level Tests recognized by the AICTE/ MHRD, Gol for admissions to MBA/PGDM courses. The national level status of ATMA has been confirmed by the Supreme Court also.

Starting from November 2014 till July, 2015, AIMS Test for Management Admissions (ATMA) is planned on the following dates at about 30 cities across the country:

Sunday, 14<sup>th</sup> December, 2014 .. Online Test (Internet Based Test)

Sunday, 08<sup>th</sup> February, 2015 .. Paper based Test with online Regn.

Sunday, 24<sup>th</sup> May, 2015 ... Online Test (IBT)
Sunday, 26<sup>th</sup> July, 2015 ... Online Test (IBT)

The test results (except for the Paper based) will be announced in about ten days from the date of conduct of the Internet Based test and the scores of the candidates opting for your Institute will be made available through website, with an individual password or by direct email to the head of the participating institute...

Any participating Institute having good computer facilities for at least 30 candidates (normally only one shift) can opt to be a Test Center for an IBT. Further, institutes also can opt for distribution of the ATMA Bulletins and AIMS will pay some remuneration for the distribution and also for testing candidates. Details of payment for Distribution of Forms/Test Centers will be sent later to those who indicate their interest in the Participation Form attached herewith.

## **About ATMA**

Started in 2000, ATMA tests the candidate's verbal, numerical and analytical abilities. The scores in each of these abilities are supplied to the participating institutions to assist them in the selection process. There are over 200 Institutes that accept ATMA scores and hey have expressed satisfaction of the quality of the test and of other services provided by ATMA. They have shown appreciation of the total transparency of the process we follow.
