Candidates applying for more than one discipline have to select all the courses at a time during online submission of application(s). system will automatically generate the no. of application form(s) required and the total amount of application fees to be deposited. Candidates have to pay total application fee (for all the application) once through State Bank of India. Candidates must keep a hardcopy (print out) of the submitted application form and e-receipt of Challan (Application Fee) to be downloaded from payment history of State Bank collect and other relevant document signed by the candidate in each pages of documents & form. All these document to be submitted for verification when called for in notice.
 - **Part-A** Candidates (current year ,C.U. Graduates) will submit printed copy of Application and other testimonials immediately after online submission as notified in Admission Schedule.
 - **Part-B** Candidates (Non C.U. graduates and C.U. previous year graduate) will submit printed copy of application and other testimonials after publication of Entrance Test Result to be notified in the Admission Schedule.
