- 5. Admission through ON-LINE MODE ONLY
- Payment for Admission Fee ON-LINE MODE ONLY 6.
- 7. All admissions should be PROVISIONAL subject to document verification after the commencement of classes.
- Applicant must NOT visit the college before the commencement of classes. 8.
- 9. Provisionally Admitted Student must report for documents verification on scheduled Date & Time after the commencement of classes (to be notified later)
- 10. Admission will be CANCELLED if during verification, the original documents are found NOT in conformity with the information submitted on-line.
- 11. Applicant must pass in English having full marks not being less than 100 in Higher Secondary (10+2) or equivalent Examination.
- 12. If the Provisionally Admitted Student fails to report for documents verification on scheduled date & Time then his/her admission will be CANCELLED.

## A candidate taking up Honours Course in a subject must have obtained:

i) A minimum of 50% marks in the aggregate and 45% marks in the subject or related subject at the previous qualifying examination.

## FOR B.A. (HONOURS) in Philosophy COURSE

If the candidate has not studied Philosophy as a subject in the previous qualifying examination then Psychology/ Math/ Education/ Sociology/ Political Science be treated as related subjects.

#### FOR B.A. GENERAL COURSE

A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the 3 year (six semesters) B.A. (General) Course of Studies provided he/she has also passed in English having full marks not being less than 100.

## FOR B.Com. HONOURS COURSE

A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the 3 year (six semesters) B.COM. (Honours) Course of Studies provided he/she has also passed in English having full marks not being less than 100 and subject to the fulfilment of the following conditions:

#### A candidate taking up B.Com. Honours Course in a subject must have obtained:

i) A minimum of 50% marks in the aggregate and 45% marks in the subject or related subject at the previous qualifying examination.

OR

ii) 55% marks in the subject or related subject at the previous qualifying examination.

However, candidates belonging to the Scheduled Caste or Scheduled Tribe Community taking up Honours Course of Study mast have obtained a minimum of 40% marks in the aggregate or 40% marks in the subject or related subject at the previous qualifying examination.

#### Following subjects be treated as related subjects for admission to B.Com. Honours courses:

## FOR B.Com. GENERAL COURSE

A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the 3 year (six semesters) B.COM. (General) Course of Studies provided he/she has also passed in English having full marks not being less than 100 and subject to the fulfilment of the following conditions:

A candidate shall be allowed to take up B.Com. (General) Course if he/she had passed the subject(s) at the previous qualifying examination as mentioned below:

Accountancy/ Business Economics including Business Mathematics/ Business Organization/ Mathematics/ Economics/ Statistics/ Commerce/ Accounts/ Business Studies/ Financial Accounting/ Office and Secretarial Practice/ Elements of Cost Accountancy and Auditing/ Book Keeping/ Business Mathematics/ Cost Accountancy & Principle of Management, , Commercial Law and preliminaries of Auditing, Costing and Taxation.

## FOR B.SC. GENERAL COURSE

A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the 3 year (six semesters) B.SC. (General) Course of Studies provided he/she has also passed in English having full marks not being less than 100 and subject to the fulfilment of the following conditions:

- A candidate shall be allowed to take up **Physics** if he/she had passed Physics and Mathematics at the previous qualifying examination.
- A candidate shall be allowed to take up **Mathematics** if he/she had passed Mathematics/Business Mathematics at the previous qualifying examination.
- A candidate shall be allowed to take up **Botany** if he/she had passed Botany/Biology/Bio-Technology at the previous qualifying examination.
- A candidate shall be allowed to take up **Zoology** if he/she had passed Zoology/Biology/ Bio-Technology at the previous qualifying examination.
- > A candidate shall be allowed to take up **Chemistry** if he/she had passed Chemistry
- > at the previous qualifying examination.
- A candidate shall be allowed to take up **Statistics** if he/she had passed Statistics/Business Mathematics / Mathematics at the previous qualifying examination.

# **Document Verification**

# (Document Verification)

(a) Document Verification of the Application Form of the Provisionally Admitted student will be done when the student report at the commencement of the classes in due course.

(b) The Provisionally Admitted student must report for Document Verification when the student report at the commencement of the classes on the scheduled date & time (to be notified later).

# (Admission Finalized/Admission Cancelled)

- a) During Document Verification, if the Original Documents are found NOT in conformity with the declaration in the forms submitted on-line, then the admission will be CANCELLED.
- b) If the Provisionally Admitted Student fails to produce the required document(s) for document verification on the scheduled date & time then the admission will be CANCELLED.
