NOTICE (Admission for NCC) Session – 2022-23

Interested students of BA, B.Sc., 1^{st} year and B. Tech 1^{st} year and 2^{nd} year (both) are requested to download and fill up the NCC form and submit the same to the NCC office, Aliah University with following instructions and documents latest by 10^{th} June 2022.

- 1. Age limit- not less than 18 years and not more than 25 years at the time of admission.
- 2. Four passport size photographs and Photocopy of Aliah University ID Card.
- 3. Photo copy of Aadhar Card/Voter Card/ PAN Card and own Bank details are necessary.
- 4. Selection procedure will be carried out as per NCC and University guidelines.
- 5. Form Fee: 100/- (Hundred Rupees only), payable at university Finance Branch and receipt of payment is compulsory to be enclosed with application form. Admission Fee 32/- (Thirty Two Rupees only) at the time admission.

After filling up prescribed form, students are asked to submit the same to NCC office of the Aliah University (Amenity Building), New Town Campus latest by 10th JUNE 2022.
