### **Session for Merit-based Selection and Admission Notification for M. Ed. (Fresher) (Session 2019-21) (Phase II)**



The candidates should take note of the following instructions:

1. The session is being conducted only for merit-based selection as per the approved intake. Document verification will be carried out later on after the conclusion of the session, after payment of admission fees through on-line mode.
2. All concerned candidates as per their rank in the merit list as stated above should **compulsorily attend** the session and in case a candidate is unable to attend, he/she should send his/her authorised representative for the session. The **vacant seats** will be filled up on the basis of the merit-based selection from amongst candidates reporting for the session.
3. Once the session for merit-based selection is completed, payment link for payment of the requisite admission fees will open through the online link that will be available in the Post Graduate Admission (Arts) page on the university website from **13.01.2020**. The selected eligible candidates should log on to payment portal by inserting SP Transaction ID provided along with their name.

4. Payment of admission Fees is to be made through Net Banking/Debit Card/Credit Card/Offline bank Challan generated through online process.
5. Candidates should ensure the generation of e-receipt of successful payment generated in the online system or SMS sent from SabPaisa to their registered mobile no. or through email to their registered e-mail id of Payment Success. Please remember that the receipt of SMS from own bank may not ensure successful payment to the designated bank account.
6. The university will not take the responsibility of any payment failure caused due to network problems.
7. The broad merit list has been prepared based on system generated data without actual document verification. Candidates are therefore requested to verify their n honours marks and in case of any discrepancy/ difference with the actual marks obtained, the same must be immediately brought to the notice (email: pgadmissionarts2019@buruniv.ac.in) before proceeding with the online admission.
8. **ALL ADMISSIONS ARE PROVISIONAL.** The mere fact that any name has been published in the admission list does not by itself ensure admission of the candidate concerned unless his/her original credentials are found in order at the time of verification of documents. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students, any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.
9. If a candidate is found, before or after admission, **not having the minimum eligibility** of admission in post graduate courses of The University of Burdwan, then university will have the right to cancel his/her admission without taking the responsibility of refund of his/her admission fees. Candidates not possessing the minimum eligibility for admission are advised not to proceed.
10. The selected candidates in Phase II should report to the department with the e-receipt of their admission Fees **immediately** after the payment of admission fees for document verification and classes.
11. All the candidates will have to produce and submit self-attested photocopies of all testimonials including the relevant certificates and final mark sheet on the date of document verification to be notified by the department, failing which their admission to Post Graduate courses will be cancelled.
