ADMISSION OF CANDIDATES WILL BE CONFIRMED ONLY AFTER DOCUMENT VERIFICATION

The counseling for admission to 3-yr LL.B.(H) Course of Studies for the session 2022-24 (BCI Session: 2021-2022) in 1) Burdwan University Campus, Burdwan, 2) Bengal Law College, Shantiniketan, Bolpur, Birbhum, 3) Amex Law College, Burdwan and 4) George School of Law, Konnagar, Hooghly, as per the broad merit list, will be held on 28.06.2022 at the Kadambini Ganguly Memorial Hall, 3rd Floor Composite Arts Building, Golapbag, the University of Burdwan from 11.00 A.M. sharp. The candidates are requested to follow the notice and to act accordingly:

The students should take note of the following points before making payment of Admission Fees:

1. Date & Time of Counseling (as follows):

Please note that the candidates, between UR Rank 137 to 209 & 958 to 1400, who were absent or provisionally selected for admission to any center of studies but did not complete the admission procedure, will not get any chance for counseling in this Phase.

It is to be notified further to all the provisionally admitted candidates between Rank 137 to 1088 that, the candidates who do not want to change the study center, are directed not to attend this Phase-3 counseling.

- 2. Provisional admission shall be done strictly on the basis of merit.
- 3. The Provisional Merit (Rank) List has been prepared by the engaged external agency based on system generated data without actual document verification. Candidates are, therefore, requested to **verify**

their eligibility in accordance with the criteria as prescribed in the Information Brochure of the 3 Year LL.B. (Honours) Admission 2022-2024 (BCI Session: 2021-2022), available in the University Website.

- 4. ALL ADMISSIONS ARE PROVISIONAL. Mere selection of candidates and payment of admission fees do not ensure confirmation of admission unless the eligibility of the candidates is checked and original credentials are found in order at the time of verification of documents. If a candidate is found, before or after admission, not having the minimum eligibility of admission, then the university will have the right to cancel his/her admission without taking responsibility of refund of his/her admission fees. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students or any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.
- 5. In case a candidate does not fulfil the eligibility and merit criteria, he/she is requested **not to proceed** with the subsequent steps since it is likely that the admission will not be confirmed.
- 6. ADMISSION OF CANDIDATES WILL BE **CONFIRMED** ONLY AFTER DOCUMENT VERIFICATION & AFTER PAYMENT OF ADMISSION FEES.
- 7. At the time of counseling all the candidates have to produce their academic and other credentials in original.
- 8. The University reserves the right to rectify the list of candidates selected for admission in the event of detection of any inadvertent error, before or after payment of admission fees including cancellation of admission.
- 9. As per the directives of the Hon'ble Supreme Court of India, it is notified that if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the institution.
- 10. Seats remaining vacant after the expiry of payment period will be filled up through another Provisional Notice for Counseling (PHASE-4) which will be published later on. Please visit the university website for any update.
- 11. The candidates who will be provisionally selected for or upgraded to **B.U. Campus** have to Pay **Rs.3215/- (Rupees three thousand two hundred fifteen only)** through online via Student Dashboard on and from 28.06.2022 to 01.07.2022 by the following link, no communication in this regard will be entertained after the expiry of payment period. University will not take the responsibility of any payment failure caused due to network problems.

The candidates who will be provisionally selected for Bengal Law College, Amex Law College & George School of Law will have to take admission at the respective Colleges by 01.07.2022 on payment of requisite admission fees otherwise his/her candidature will be treated as cancelled. Each Candidate, who will opted new center as fresh admission or as upgradation, has to pay the prescribed admission fees of the center which he/she will opt. In Case of upgradation or changing of colleges, the candidates shall apply the concerned college for necessary refund as per Govt. rules.

- 12. The candidates who will be selected provisionally for Bengal Law College, Amex Law College & George School of Law will have to pay initially Rs. 6000/- (Rupees six thousand only) as token fees for seat booking on the date of counseling to the representative of the concerned college and later on they have to take admission by providing other admissible fees within the stipulated time. Selected candidates, if not formally takes admission/pays admissible fees within the stipulated period, his/her admission will be treated as cancelled.
- 13. Options for Centre of Learning, once exercised, cannot be changed in any case in future unless they get the chance of up gradation against any vacancy, created later on.
- 14. If any candidate or his/her authorized representative fails to turn up on the date and time of counseling, will not be considered for admission in the later stage.

- 15. Non-payment of admission fees by the selected candidates shall amount to cancellation of his/her candidature and in such context, they will be debarred from participation in any subsequent phase of the admission process.
- 16. Seats are limited and will be available on the basis of merit and hence, mere participation in the counseling or mere notification for attending counseling do not ensure seats to the candidates as number of seats are lesser than the number of applicants.
- 17. The University reserves the right to include/exclude any name of the candidate if any suppression of fact on the part of the candidate or any mistake in calculating the marks/rank in detected subsequently.
- 18. As per the reservation rules vide Govt. Order No.: 07-Edn (U)/1U-89/13.- dated. 2nd January, 2014 "for admission to different courses, an SC or ST candidate getting admission should have obtained in the previous examination; qualifying marks not lower by more than 25% of the marks obtained by the last candidate of the general category."
