

NOTICE:

For Kind Attention of Final Semester Students of FET and Arts Faculty:

The following Resolutions were resolved and confirmed by the Examination Board in terms of Clause-37 of JU First Regulations (Chapter III) in its meeting of 08 June 2020 held on virtual mode at 4 P.M.

1. In view of the present pandemic the evaluations of final semester of the final year UG and PG courses, including the Evening courses, will be based on non-contact distant mode. However, an option will be made available for submission and evaluation of dissertations in post-graduate FET courses. For UG evening courses a separate Notification will be issued later on.

2. For FET the following modalities were decided upon:

The evaluation will be based on 30:70 model: 30% based on the best aggregate marks for all last semesters of each candidate and 70% to be based on home-assignment/s or any other NON-CONTACT DISTANCE MODE. The mode of conducting the evaluation in NON-CONTACT DISTANCE MODE will be decided by the respective Departments. It is proposed that at least 24 hours will be given to each candidate for the submission of an assignment under this mode.

3. For the Faculty of Arts, the following modalities will be followed:

- (i) The total marks for the final semester for the final year UG and PG will be divided between internal assessment (20) and end semester marks (30) for departments in general. Exception is made for Physical education where internal assessment is for 30 marks and end semester is for 70 marks. Similarly, for B. Ed, internal assessment is for 25/50 marks and end semester is for 50/25 marks. For library science, internal assessment is 25 and end semester is also 50 marks.
- (ii) Regarding mode of final semester examinations for the final UG and PG years, the following resolution is made:
 - The final semester examination will be held in non-contact mode. It is resolved that following two alternative modes will be followed- one is that the department will give 20 marks for internal assessment/s based on the best aggregate marks from all the previous semesters and 30 marks of end semester will be taken in the form of internal assessment/s already done in the final semester and additional home assignment/s in

distant mode. The other one is that internal assessment/s of 20 marks will be taken from assignments done in the class or in distant mode and 30 marks for end-semester examination will be taken from the best aggregate marks from all the previous semesters.

- The departments will have freedom to choose **any one** based on one of these two modes. The HOD will send the option to be adopted by the Department on the basis of a statement that it is being done through consultation with the Departmental colleagues
- The last date of submission of assignments for internal assessment will be determined by the respective departments, but not later than July 15, 2020. However, for end-semester home assignments the maximum time allowed will be 3 days from the date of examination announced if submitted by email but will be seven days if someone does not have internet connectivity and needs to submit hard copies.
- The format of internal assessment as well as end-semester home assignments is left to the departments and may include a dissertation / project report / field survey report / practical.

The students are advised to contact their HODs for further details concerning the implementation of the above decisions.
