The Vice-Chancellor's Office, Registrar's Office, Finance Office, the Examination Department would function for emergency evaluation work of different examinations and all other administrative Departments will remain remain functional between 16th March, 2020 and 31st March, 2020 in view of financial year ending. The IQAC will remain open for the completion of all work regarding NAAC Peer team visit. All Heads of the Departments and teachers are requested to cooperate with the IQAC as and when required. All University examinations are suspended and will be rescheduled in due course of time. All Seminars, Conferences, Public Lectures, Workshops and large gatherings scheduled to be held in the campus will remain suspended or postponed until further orders. All stakeholders including students of the Vidyasagar University are requested to avoid large gatherings at the campus.
